- 2.ASC100/19/B.Tech/KSFECMA Approval of Prospectus & Notification in Respect of Kerala Self Financing Engineering College Management's Association dated 25.06.2019

ORDER

1. The Admission Supervisory Committee, herein after referred as ASC, through communication referred as 1st paper above, has directed the Principal, Sreepathy Institute of Management & Technology, Vavanoor, Palakkad in short the Institute, to produce the list and supporting documents of the admitted candidates in respect of B.Tech Course for the academic year 2019-20.

- **2.** Accordingly, the Principal has deputed Prof. Thankachen P V, of the Institute to appear before the Committee with the list and supporting documents in respect of the admitted candidates for B.Tech Course 2019-20.
- **3.** The Institute is one of the Member Colleges of the Kerala Self Financing Engineering College Management Association (KSFECMA). The KSFECMA submitted the Common Prospectus on 20.06.2019 for approval of ASC. The Admission Supervisory Committee scrutinised the same and provisionally approved the Common Prospectus through communication 2nd Paper referred above.
- **4.** The ASC scrutinised the documents submitted by the Institute and found that the Institute is having an intake strength of Two Hundred and Fifty Three (253) Seats including 5% supernumerary Tuition Fee Waiver Scheme Seats under different branches. The Institute has submitted the AICTE Extension of Approval order and the Extension of Provisional affiliation order issued from the KTU for the Academic Year 2019-20, for conducting the above course.
- **5.** The ASC while approving the Prospectus has directed the Engineering Colleges to invite the application from the candidate through online. Accordingly the Institute has submitted the online application of the candidates. On scrutiny of the online application, the ASC found that the Photo and signature of the candidates is not seen uploaded at the time of submission of online application. Since the procedure of inviting application through online is implemented from this year, the ASC take a lenient view and decided to approve the admissions of the above candidates this Academic Year. The Principal

of the College is hereby directed that this shall not be taken as a precedent for the next Academic Year.

6. The Committee scrutinised the list and supporting documents submitted by the Institute and found that the Institute has admitted One Hundred and Fourteen (114) candidates. The Institute has admitted Nineteen (19) candidates under Government quota, Forty Eight(48)candidates under Management Quota, Thirty Five (35) candidates under NRI Quota and Twelve (12) candidates under Merit Lapsed NRI seats under different branches of B.Tech.

7. The Committee scrutinised the documents submitted by the Institute and found that Forty Eight (48) candidates are admitted under Management Seats and the documents of the above One Hundred and Forty Eight (48) candidates are acceptable and are eligible for

admission under Management Quota Seats. Therefore, the admissions of the above Forty Eight (48) candidates admitted under Management Quota are hereby approved, as per the list shown as Annexure I.

- 8. The ASC also scrutinised the list and documents of Thirty Five (35) candidates admitted under NRI quota and found that the documents submitted by the College are proper and acceptable for admission to NRI Category. Therefore, the admissions of the Thirty Five (35) candidates admitted under NRI category are hereby approved, as per the list shown below as Annexure II.
- **9.** The College admitted **Twelve (12)** candidates under Merit Lapsed NRI Seats. Clause 2.16 (j) of the AICTE Approval Process Handbook 2019 would read,

"Besides this, any vacant seat in the "Approved Intake" after the last round of the admission of the Concerned State Government/UT, may be filled with NRI/Foreign Nationals/Overseas Citizen of India (OCI)/Persons of Indian Origin (PIO)/Children of Indian Workers in the Gulf Countries, subject to the approval from AICTE for the above seats and fulfilment of requisite norms as specified in the Approval Process Hand Book."

10. On the basis of the above provision in the AICTE Approval Process Hand Book, the Government issued GO (Rt) No.1442/2018/H.Edn dated 25.07.2018 wherein it is stated that,

" If any College is granted permission by the All India Council for Technical Education (AICTE) to admit students under NRI and /or PIO/OCI/FN, then on completion of the allotment process by the Commissioner for Entrance Examinations, if any seats are lying vacany, those seats could be filled with the candidates belonging to NRI/PIO/OCI/FN. However the Colleges shall not admit any students in excess than the approved intake(for Colleges having approval for OCI/PIO/FN, the total admissions shall not exceed approved intake + 15% supernumerary"

11. In the light of the above provision in the AICTE Approval Process Hand Book and GO (Rt) No.1442/2018/H.Edn dated 25.07.2018, the admissions of the above Twelve (12) Merit Lapsed NRI Candidates are hereby approved. The list of approved Merit Lapsed NRI candidates is shown below as Annexure III.



Sreepathy Institute of Management &

Technology, in short, the Institute, is one of the members of Kerala Self Financing Engineering College Managements Association (KSFECMA) in short the Association. Through the letter dated 02.05.2016, the Association President was directed to submit the prospectus of 2016-17 of B.Tech course of the Member Colleges. In reply through letter dated 01.05.2016, the Secretary of the Association had enquired whether they have to submit the prospectus

prior to the execution of the agreement or after the execution of the agreement with the Government.

In reply, the Admission Supervisory Committee, in short the ASC, clarified that the prospectus need to be submitted only after the execution of the agreement, so as to avoid the repetition of facts and figures both in the prospectus as well as the agreement approval order.

From the **G.O** (Ms.) No. 155/2016/H.Edn. dated 30.06.2016, it is seen that an agreement was executed by the Association with the Government of Kerala on 28.06.2016. Though, the dealing Officer of the ASC, has contacted the President and Secretary of the association, for the Prospectus and the copy of the agreement, none of them had submitted the same. Hence, both the common prospectus and the agreement dated 28.06.2016, have not been approved so far.

The President and Treasurer of the Association met the Chairman of the ASC on 22-09-2016 and requested to exempt the submission of Prospectus for 2016-17, as the agreement is already executed and the G.O passed.

In order to save time, and the academic opportunities of the students basing on the Government Order dated 30.06.2016, the approval of admitted students of individual colleges are being processed after scrutiny of the submitted admitted lists.

The Engineering College has submitted the lists of 2016-17 B.Tech Course for various branches.

The scrutiny of the documents submitted for **Civil Engineering** branch reveal that it got an intake strength of 60. The admitted strength is 50. The CEE allotted 24 candidates including candidates under TFW scheme. The Engineering College admitted 17 under Management seats and 9 under NRI seats. On scrutiny of the documents submitted by the college, it is found that all the documents are acceptable. Hence the admission of all the 17 management seats candidates are approved.


